

PARTNERSHIP BETWEEN NASADHH AND GALLAUDET UNIVERSITY DEPARTMENT OF GOVERNMENT AND PUBLIC AFFAIRS CREATED March 24, 2016

The National Association of State Agencies of the Deaf and Hard of Hearing's commitment to increasing opportunities to provide high-quality services to Deaf and Hard of Hearing people was on display Thursday, March 24, 2016 at Gallaudet University in Washington, D.C. In a formal ceremony, Steven Florio, President of NASADHH's Board of Directors, and Roberta "Bobbi" Cordano, President of Gallaudet University, signed an agreement to create a partnership between NASADHH and Gallaudet's Department of Government and Public Affairs.

NASADHH is a national organization comprised of administrators of state commissions, divisions and offices serving Deaf, Hard of Hearing, Deaf-Blind and Late-Deafened individuals. NASADHH's purpose is to function as the national voice of these state agencies and promote the implementation of best practices in the provision of services to these individuals.

To underscore the significance of the new partnership, in attendance for the ceremony were a number of high-level officials representing Gallaudet University as well as several representatives of NASADHH who travelled from surrounding states. Steven Florio noted, "This partnership represents a historic opportunity for Gallaudet University and State Agencies to exchange knowledge, expertise and resources vital to enhancing the lives of Deaf, Hard of Hearing and Deaf-Blind people all across the nation." The partnership will provide opportunities for internships, employment and professional development.

Following the signing ceremony, NASADHH representatives spoke for over an hour about their respective agencies and fielded questions from the approximately 25 undergraduate and graduate students from the Department of Government and Public Affairs.
