**10:30- 11:30:** Panel session on Over-the-Counter Hearing Aid Act (moderated by Marilyn Call)

Panelists are invited to discuss on the benefits and ramifications on the proposed congressional legislation on hearing aids that will create a marketplace that will make hearing aids easier to access over the counter (OTC) and removing the requirement of a medical evaluation. Marilyn Call, Director for the Utah Division of Services for the Deaf and Hard of Hearing will moderate the panel discussion.

The bipartisan bill, Over-the Counter Hearing Aid Act of 2016 (SB 9) would make certain types of hearing aids available over the counter (OTC) and remove “unnecessary and burdensome” requirements that currently create barriers for many consumers who could benefit from hearing aids.
